FRR & IMX Affiliation Update

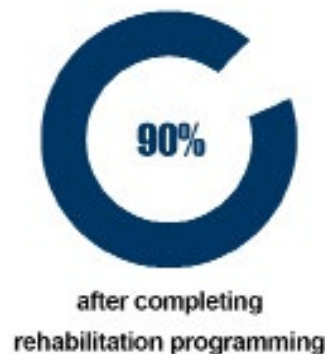

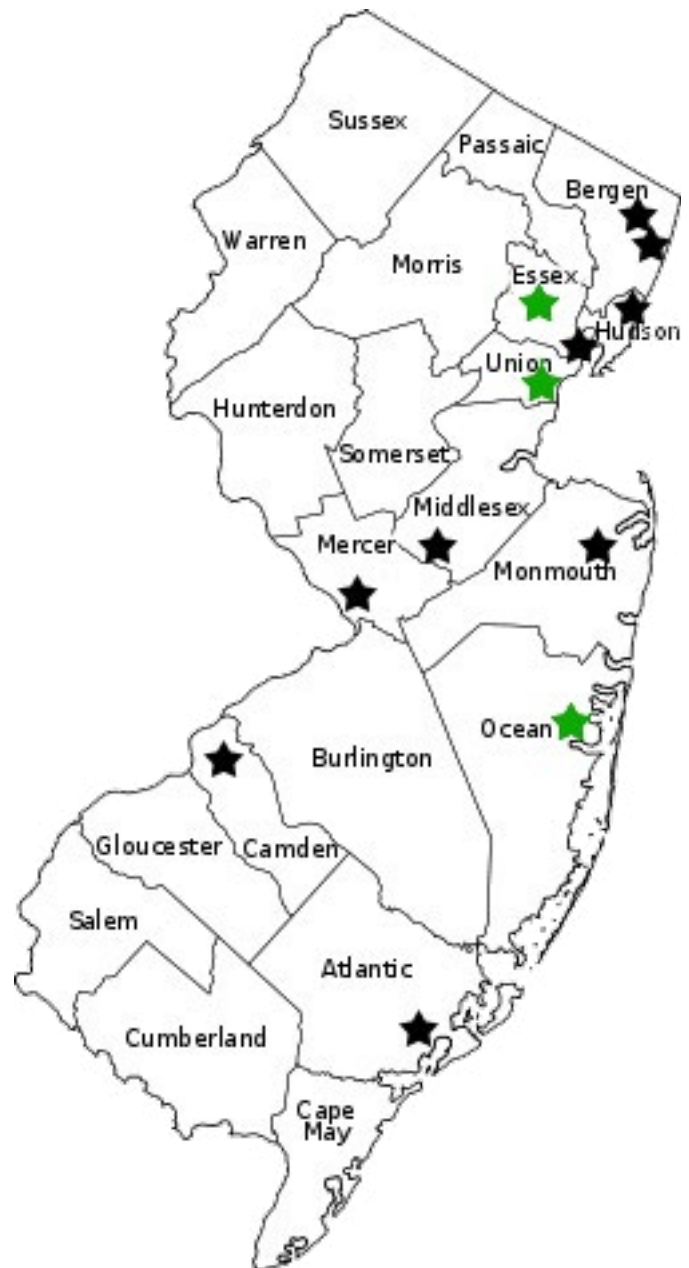

IMX at Kids' Chance Bowling Night!

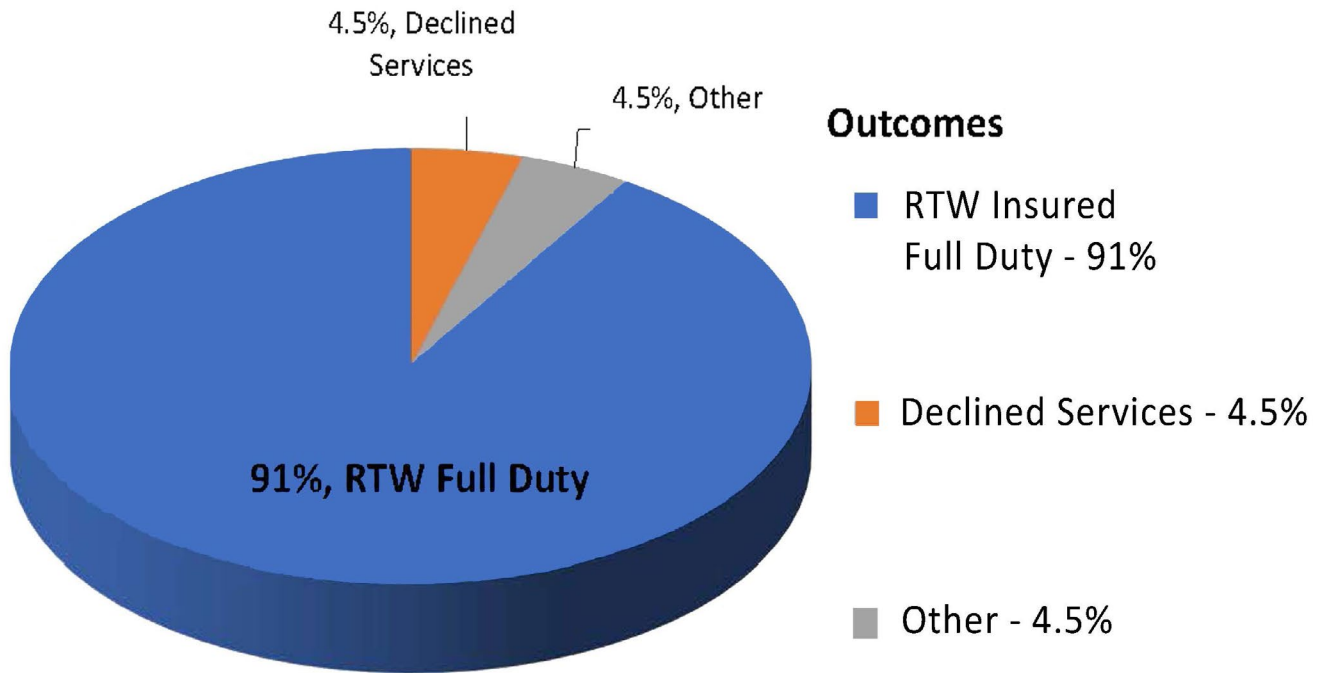
